NARRATIVE

ON LISTED DATE AND TIME AT THE LISTED LOCATION THE COMP AND AP WERE INVOLVED IN A PHYSICAL ALTERCATION ON WHICH THE AP WALKED UP BEHIND THE COMP AND SHOVED HIM CAUSING THE COMP'S HEAD TO STRIKE A DRINKING GLASS WHICH CAUSED MINOR LACERATION TO THE COMP NOSE. ROS ASKED THE COMP IF HE NEEDED DFR TO THE LOCATION AND WAS REFUSED. THE COMP AND WIT #1-3 ALL STATED THAT THE AP JUST WALKED UP BEHIND THE COMP AND STATED "WHAT YOUR PROBLEM FAGGOT" THEN SHOVED THE COMP THEN WALKED AWAY. ROS ASKED THE COMP IF ANY WORDS WERE EXCHANGEDD PRIOR TO THE ALTERCATION WHICH HE REPLIED "MAYBE". ROS ASKED THE COMP TO EXPLAIN THE ANSWER HE GAVE TO RO. THE COMP STATED HE MIGHT OF SAID SOMETHING TO THE AP. THE RO THEN TALKED TO THE AP WHO STATED THAT THE COMP WAS WHISTLING AND MAKING SEXUAL GESTURES AT WIT #4 AND ASKED THEM TO STOP WHEN THE COMP REFUSED TO STOP; THE AP SHOVED THE COMP. ROS ISSUED THE AP A CITATION FOR ASSAULT. AND RELEASED BOTH PARTIES TO THEIR HOTEL ROOMS. END OF ELEMENTS  
XXXXXXXXXXXXX ROS ASKED THE COMP WHAT HE WANTED THE ROS TO DO WITH THE AP, WHICH THE COMP REPLIED WHAT DO YALL NORMALLY DO FOR AN ASSAULT. RO EXPLAINED TO THE COMP WHAT WAS GOING TO HAPPEN WHEN WIT#2 BECAME IRATE AND STATED THAT THE AP DID IT BECAUSE THEY WERE HOMOSEXUALS. THE COMP THEN BECAME UPSET ALONG WITH WIT#1&3 AND STATED TO ROS THAT THE AP NEEDED TO GO TO JAIL BECAUSE IT WAS A HATE CRIME, AND THAT HE WAS GOING TO CALL THE NEWS MEDIA OUT TO THE LOCATION BECAUSE ROS DID NOT TAKE THE AP TO LEW STERRETT. RO DID NOT TAKE THE AP TO LEW STERRETT DUE TO THE CONFLICTING STORIES ON BOTH PARTYS ABOUT WHAT HAD HAPPENED. BOTH PARTIES WERE INTOXICATED. RO RELEASED BOTH PARTYS BACK TO THEIR HOTEL ROOMS.
